This itinerary acts as confirmation of payment for your booking. You will need to bring this, your passport, travel insurance details, COVID RAT booking confirmation and your signed code of conduct form to travel.

### IMPORTANT INFORMATION

- **Passport** – Please ensure that your passport is in good condition and valid for 6 months from your return date.
- **Travel Insurance** – It is a mandatory requirement for entry into Fiji that every traveller has a valid travel insurance policy. Please ensure you have a copy of your policy with you when travelling. \*\*\*Double check your travel dates match your policy dates.
- **International COVID vaccination certificate** - Please be aware this is separate to your state based certificates. To find out more please follow the instructions by Services Australia found [HERE](#)
- **Accidental Damage Protection (ADP)** – If you have paid for Accidental Damage Protection you will be listed with the resort and will not need to provide a security bond.

### PRE DEPARTURE CHECKLIST

- Check your name is spelt exactly as per passport.
- Pack your passport, international COVID vaccination certificate, travel insurance documents and COVID RAT confirmation.
- Check your Passport has 6 months validity from return date.
- Check if you require a Visa (not applicable for AUS/NZ passport holders in Fiji).
- Organised transport to the Airport, you must arrive at least 3 hours prior to your flight.
